"Release and Hold Harmless Agreement"

"As a participant in the program, I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries, damages or losses which I may sustain as a result of participating in any and all activities connected with or associated with such program. I do hereby fully relinquish all claims I may have and discharge the Northfield Park District and its officers, agents, servants and employees from any and all claims from injuries, damages losses which I may have or which may accrue to me on account of my participation in the program. I further agree to indemnify and hold harmless and defend the Northfield Park District and its officers, agents, servants, and employees from any and all claims resulting from injuries, damages and losses sustained by me and arising out of, connected with, or in any way associated with the activities or the program."

Warning of Risk

Recreational activities/programs are intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury when participating in any recreational activity/program. COVID-19 Wellness Screening

All patrons should ask the following questions when determining whether or not they should attend Northfield Park District programming each day:

- Have you felt feverish or do they have a temperature of 100.4 degrees or above?
- Do you have a cough?
- Do you have a sore throat?
- Have you been experiencing difficulty breathing or a shortness of breath?
- Do you have muscle aches?
- Have you had a new or unusual headache (e.g., not related to caffeine, diet, or hunger, not related to a history of migraines, clusters, or tension, not typical to you)?
- Have you noticed a new loss of taste or loss of smell?
- Have you been experiencing chills or rigors¹?
 - * ¹Rigors: a sudden feeling of cold with shivering accompanied by a rise in temperature.
- Do you have any gastrointestinal concerns (e.g., abdominal, pain, vomiting, diarrhea)?
- Is anyone in your household displaying any symptoms of COVID-19?
- To the best of your knowledge, have you or anyone in your household come into close contact² with anyone who has tested positive for COVID-19?
 - * Close contacts include household contacts, intimate contacts, or contacts within 6-ft. for 15 minutes or longer (10 minutes or longer for ambulatory care services) unless wearing N95 mask during period of contact.

If the answer to any of these questions is "yes", please STAY HOME and it is strongly recommended to seek a COVID-19 test.

I acknowledge receipt of the COVID-19 screening questions above and agree to conduct a brief screening each day when deciding to attend programs at the Northfield Park District. By attending this program, I am certifying that I am exhibiting any of the symptoms of COVID-19.
