## **Waiver & Release of All Claims**

#### "Release and Hold Harmless Agreement"

"As a participant in the program, I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries, damages or losses which I may sustain as a result of participating in any and all activities connected with or associated with such program. I further agree to indemnify and hold harmless and defend the Northfield Park District and its officers, agents, servants, and employees from any and all claims resulting from injuries, damages and losses sustained by me and arising out of, connected with, or in any way associated with the activities or the program."

#### Warning of Risk

Recreational activities/programs are intended to challenge and engage the physical, mental and emotional resources of each participant.
