This program is tailored for families enrolled in the Northfield Community Nursery School and runs everyday that NFCNS is in session, starting Monday, September 18, 2023. Drop your NFCNS students off at the Northfield Community Center as early as 8:30am! Children will enjoy free play and some structured activities under NPD staff supervision.

Park District staff will board children onto our bus and take them to NFCNS for the classes each day, 12:15pm on Mondays, Tuesdays, and Wednesdays, and 10am on Thursdays and Fridays. Children must be enrolled in NFCNS Enrichment program to register for Thursday and/or Friday Pre Pre-K.

Pre Pre-K requires at least 2 children registered for each specific day to run. The deadline for this minimum to be met is by 10am on Friday, September 8th. # Waiver & Release of All Claims

## **"Release and Hold Harmless Agreement"**

"As a participant in the program, I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries, damages or losses which I may sustain as a result of participating in any and all activities connected with or associated with such program. ## **Warning of Risk**

## Transportation Services Waiver and Release
